FOREWORD

THE UNIVERSAL DECLARATION OF HUMAN RIGHTS WILL BE 75 YEARS OLD IN DECEMBER 2023. THE RETHINK EDUCATION AND SCIENCE IN IRAQ (RESI) HUMAN RIGHTS WEEK IS A WEEK OF SCHOLARLY EVENTS TO COMMEMORATE THIS OCCASION BY DISCUSSING AND PROMOTING THE UNDERSTANDING OF HUMAN RIGHTS ACROSS ACADEMIC DISCIPLINES, CULTURES, LANGUAGES, AND GENERATIONS. HUMAN RIGHTS ARE NOT A RECENT INVENTION AND ARE FOUND IN VIRTUALLY EVERY AREA OF HUMAN ACTIVITY. THROUGHOUT HISTORY, CONCEPTS OF ETHICAL BEHAVIOUR, JUSTICE, AND HUMAN DIGNITY HAVE BEEN IMPORTANT IN THE DEVELOPMENT OF HUMAN SOCIETIES OVER THOUSANDS OF YEARS. THEY HAVE THE POWER TO BIND US TOGETHER THROUGH A SHARED SET OF RIGHTS AND RESPONSIBILITIES.

DUE TO EXISTING INJUSTICES, HUMAN RIGHTS NEED TO BE CONSTANTLY DEFENDED, DEMANDED, FOUGHT FOR, AND DISCUSSED IN TERMS OF THEIR MEANING FOR PEOPLE IN VERY DIFFERENT LIFE SITUATIONS. OUR ACTIVITIES IN THE RESI HUMAN RIGHTS WEEK ARE DESIGNED TO STIMULATE DISCUSSIONS AND PROMOTE UNDERSTANDING OF HUMAN RIGHTS ISSUES AT LOCAL, NATIONAL, AND INTERNATIONAL LEVELS. THE HUMAN RIGHTS WEEK CONSISTS OF A SERIES OF ACADEMIC, ARTISTIC, AND EDUCATIONAL ACTIVITIES TO BRING TOGETHER STUDENTS, LECTURERS AND PROFESSORS FROM MOSUL, GRAZ AND TU DORTMUND UNIVERSITY, AS WELL AS ALL THOSE INTERESTED, TO ENGAGE WITH THE MANY DIMENSIONS OF HUMAN RIGHTS.

ALL ACTIVITIES WILL TAKE PLACE FROM 18-21 SEPTEMBER IN THE CENTRAL LIBRARY OF MOSUL UNIVERSITY.

RESI IS A UNIVERSITY COOPERATION BETWEEN THE UNIVERSITY OF GRAZ (AUSTRIA), THE UNIVERSITY OF MOSUL (IRAQ) AND THE TU DORTMUND UNIVERSITY (GERMANY) WITH THE AIM TO SUPPORT THE UNIVERSITY OF MOSUL IN IT'S ACADEMIC REHABILITATION. LIKE ALL RESI ACTIVITIES, HUMAN RIGHTS WEEK IS ORGANISED BY AN INTERNATIONAL, INTERDISCIPLINARY STEERING COMMITTEE OF ACADEMICS UNDER THE LEADERSHIP OF PROF. DR. HEIKE WENDT (UNIVERSITY OF GRAZ).

IRAQ ISSUED ITS FIRST CONSTITUTION IN 1925, AND IT WAS AN ADVANCED CONSTITUTION THAT INCLUDED MANY RIGHTS AND FREEDOMS. WITH THE COLLAPSE OF THE MONARCHY IN IRAQ ON 14 JULY 1958, PROVISIONAL CONSTITUTIONS WERE ISSUED THAT ALSO INCLUDED MANY RIGHTS AND FREEDOMS, BUT THEY WERE UNDER DICTATORIAL REGIMES AND A STATE OF INSTABILITY. UNTIL THE FALL OF THE IRAQI REGIME IN 2003 AND ITS OCCUPATION BY THE UNITED STATES OF AMERICA. THE PERMANENT CONSTITUTION OF IRAQ WAS ISSUED IN 2005, WHICH IS THE SECOND PERMANENT CONSTITUTION IN THE HISTORY OF THE MODERN STATE OF IRAQ. THIS CONSTITUTION INCLUDED A SECTION ON RIGHTS AND FREEDOMS, BUT THERE ARE SEVERAL LIMITATIONS IN IRAQI LEGISLATION IN THIS REGARD. WE ARE TALKING HERE ABOUT THE REALITY OF HUMAN RIGHTS IN IRAQ IN THE LIGHT OF INTERNATIONAL STANDARDS, WHAT ARE THE MAIN CRITICISMS OF THE IRAQI LEGAL SYSTEM, WHAT ARE THE TREATIES THAT IRAQ HAS JOINED AND WHAT ARE THE RESERVATIONS THAT IRAQ HAS MADE TO THESE TREATIES.

WHOEVER WANTS TO STAND UP FOR HUMAN RIGHTS OR INVOKE THEM MUST KNOW THAT THEY EXIST. DUE TO EXISTING INJUSTICES, HUMAN RIGHTS MUST BE CONSTANTLY DEFENDED, DEMANDED, FOUGHT FOR AND DISCUSSED IN TERMS OF THEIR SIGNIFICANCE FOR PEOPLE IN VERY DIFFERENT LIFE SITUATIONS. THE WORKSHOP INVITES STUDENTS TO PERSONALLY REFLECT ON THEIR OWN UNDERSTANDING OF HUMAN RIGHTS AND TO THINK ABOUT THE MEANING OF DIGNITY, FREEDOM, EQUALITY, SOLIDARITY, JUSTICE AND CITIZENSHIP. THESE IDEAS ARE CAPTURED IN A PROCESS OF DRAWING. THUS, IDEAS BECOME VISIBLE AND INVITE FURTHER UNDERSTANDING AND DISCUSSION.

WHILST ALLOWING FOR NOVEL FORMS OF PARTICIPATION AND MEANS TO EXERCISE HUMAN RIGHTS, TECHNOLOGIES IN GENERAL AND APPLICATIONS OF AI ('ARTIFICIAL INTELLIGENCE') IN PARTICULAR SIMULTANEOUSLY POSE NEW THREATS. ALLOWING FOR AUTOMATED SURVEILLANCE, MAKING BIASED DECISIONS, AND FAVOURING HARMFUL DISCOURSES IN DIGITAL SPACES, THESE SYSTEMS MAY BE COMPLICIT IN THE VIOLATION OF HUMAN RIGHTS AND THE PERPETUATION OF INEQUALITIES. THIS TALK AIMS TO HIGHLIGHT HOW DIGITAL TRANSFORMATIONS ARE AFFECTING HUMAN RIGHTS, BUT ALSO HOW HUMAN RIGHTS (AND THEIR DIGITAL TRANSFORMATION) MAY BE THE BASIS TO FOSTER FURTHER TECHNOLOGICAL ADVANCES TOWARDS A HUMAN CENTRED DEVELOPMENT.

THOMAS ZENKL IS A RESEARCH ASSISTANT AT THE INSTITUTE OF SOCIOLOGY OF THE UNIVERSITY OF GRAZ. IN HIS PHD THESIS, HE IS INTERESTED IN THE SOCIETAL EMBEDDING OF AI AND ALGORITHMIC SYSTEMS AND THE SOCIAL CONSEQUENCES, DISRUPTIONS, RESISTANCES, AND TRANSFORMATIONS ARISING FROM THE APPLICATION OF AUTOMATED SYSTEMS.

HOW CAN WE CREATE A WORLD WHERE EVERYONE'S HUMAN RIGHTS ARE RESPECTED?

THERE IS A GROWING RECOGNITION OF THE IMPORTANCE OF EDUCATION IN PROMOTING HUMAN RIGHTS, PREVENTING HUMAN RIGHTS VIOLATIONS AND CONFLICTS, AND ADDRESSING THE ROOT CAUSES OF CONFLICT SUCH AS POVERTY, INEQUALITY AND DISCRIMINATION. AT PRESENT, WE SEE A WIDE VARIETY OF APPROACHES BEING APPLIED, RANGING FROM TARGETED TRAINING TO VERY HOLISTIC APPROACHES LINKING EDUCATION WITH OTHER KEY SECTORS SUCH AS HEALTH, JUSTICE AND SECURITY. THE ROLE THAT ONLINE PLATFORMS, SOCIAL MEDIA AND MOBILE APPLICATIONS CAN PLAY REMAINS TO BE EXPLORED.

HUMAN RIGHTS ARE A FUNDAMENTAL ASPECT OF POST-CONFLICT TRANSFORMATION, PROVIDING A FRAMEWORK FOR ENSURING JUSTICE, EQUALITY AND DIGNITY FOR ALL. SOCIETIES EMERGING FROM ARMED CONFLICT OFTEN FACE MANY CHALLENGES IN REBUILDING AND ESTABLISHING A PEACEFUL AND INCLUSIVE SOCIETY. HUMAN RIGHTS PLAY A CRUCIAL ROLE IN ADDRESSING THESE CHALLENGES AND PROMOTING SUSTAINABLE PEACE. POST-CONFLICT TRANSFORMATION ENCOMPASSES VARIOUS PROCESSES AIMED AT REBUILDING SOCIETIES AFFECTED BY ARMED CONFLICT. THESE PROCESSES INCLUDE DISARMAMENT, DEMOBILISATION AND REINTEGRATION OF FORMER COMBATANTS, RECONCILIATION EFFORTS, JUSTICE AND ACCOUNTABILITY MECHANISMS, INSTITUTIONAL REFORMS AND SOCIO-ECONOMIC DEVELOPMENT INITIATIVES. TO WHAT EXTENT CAN HUMAN RIGHTS SERVE AS A GUIDING FRAMEWORK IN THESE PROCESSES?

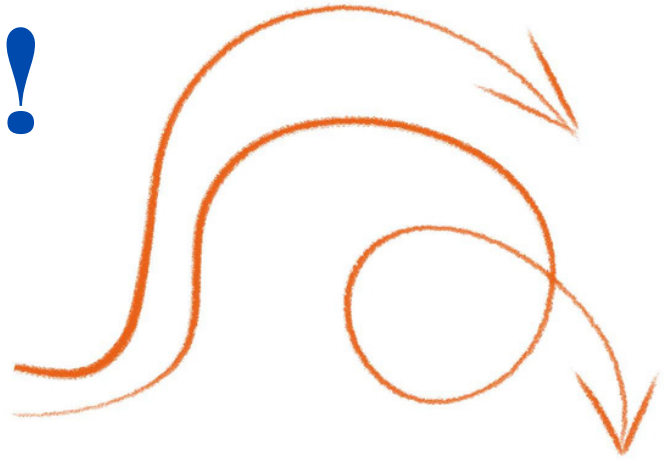
